About the Author



Andrew Palmer is retired Professor of the Center for Offshore Research and Engineering of the Department of Civil & Environmental Engineering of the National University of Singapore (2006–2015), as well as retired Jafar Research Professor of Petroleum Engineering, Cambridge University, UK. He is a Fellow of the Royal Society, a Fellow of the Royal Academy of Engineering, a Fellow of the Institution of Civil Engineers, and a Chartered Engineer in the UK.

He has divided his career equally between practice as a consulting engineer and university teaching. He was appointed as a Lecturer in the Department of Mechanical Engineering of the University of Liverpool in 1965, and in 1968 as a University Lecturer in the Department of Engineering in the University of Cambridge. In 1975 he joined R.J. Brown and Associates, a company of consulting engineers based in the Netherlands, and was appointed Chief Pipeline Engineer in 1976. In 1979 he was appointed as Professor of Mechanical Engineering in the Department of Mechanical Engineering of the University of Manchester Institute of Science and Technology. In 1982 he returned to R.J. Brown and Associates as Vice-President Engineering, responsible for technical development and innovation.

In 1985 he founded Andrew Palmer and Associates, a company of consulting engineers principally engaged with marine pipelines, but also in defence and Arctic engineering. The company grew to 55 people in offices in London, Glasgow and Aberdeen. The company was bought by Science Applications International Corporation in 1993, and later bought by Penspen.
